8. PYS 4246 - Dissertation

The Objectives

- To critically read, understand and evaluate current literature in the discipline of Philosophy.

- To demonstrate comprehensive knowledge of the literature in the field.
- To critically evaluate empirical evidence.
- To demonstrate a comprehensive understanding of techniques critical to scholarship in the field.

Learning Outcomes

The dissertation provides evidence the students is able to:

- Review and summarize the literature in the field.
- Identify or define problems, generate questions and/or hypotheses.
- Apply appropriate research methods and collect data systematically.
- Evaluate, interpret, and analyze a body of empirical data and evidence.
- Discuss finding in the broader context of the field.
- Develop and sustain an evidence-based argument.

This course is entirely devoted to research and dissertation writing. Each student is guided by a senior lecturer in Philosophy (Supervisor) appointed by the department. Before students begin writing their dissertations, they were having an opportunity in first semester to present their research findings in the lecture room and obtain suggestions from the academic staff as well as the colleagues. Students are expected to maintain a record of consultations with the supervisor and annex it to the dissertation, submitted for evaluation.
